### OFFICIAL TOURNAMENT RULES

1. Tournament is open to USBC certified bowlers who live or bowl regularly in Michigan, Sault Ste. Marie, Ontario and any other area authorized by the tournament committee.
2. Use HIGHEST USBC certified league average, 21 games or more, as of the end of the 2024-2025 bowling season as filed with the City Association Secretary. If no 2024-2025 average, use highest current USBC certified league average, 21 games or more, **at time of** bowling. Summer league and YABA league averages are not recognized. All others bowl 210 scratch. **10 pin rule will apply. FAILURE TO USE CORRECT AVERAGE SHALL DISQUALIFY SCORE IF SUBMITTED AVERAGE IS LOWER THAN CORRECT AVERAGE.** Prize winnings shall be based on the submitted average if it is higher than the correct average. However, corrections in averages are permitted up to the completion of the first game of a series. See Rule 319A. All averages not verified by time of bowling will be 210 scratch. Rule 319E is waived.
3. When more than three players bowl together more than once in a 5 man event, the team on which they bowl shall be eligible for only one position standing prize. Doubles - in no case shall the same team be permitted to place more than once in position prize standings. In the Singles Event, the same person can place only once. See Rule 315. Contestant's first score in any event shall count toward their "All Events" total.
4. All prize fees returned 100% within each event. Team, doubles and singles prize ratio at least one for eight. All events prize ratio at least one for fifteen. In case of a tie for any position, position prizes will be combined and split equally.
5. **Bowlers who qualified for a prize of \$300.00 or more in value in any tournament during the previous twelve month period must report to tournament secretary prior to bowling for possible rerating. Rerating will be accomplished prior to bowling. See Rule 319C and 319D.**
6. Bowlers entering team, doubles and singles may participate in All-Events by paying \$4.00 **prior** to bowling their first event. Bowlers may participate in All-Events one time only. Rule 306.
7. One game handicap will be 85% for each bowler per event from 210 scratch.
8. All lineup changes other than substitutions must be made at least 24 hours prior to bowling.
9. Any appeal or protest must be made in writing and received prior to the distribution of prizes.
10. **Bowlers entering doubles must enter singles. Bowlers entering singles must enter doubles.**
11. Teams are responsible for FULL PAYMENT 1 HOUR BEFORE THE TIME OF BOWLING. No refunds as per Rule 314. **No date and time can be guaranteed unless a deposit at least the amount of the prize fund for the scheduled events accompanies the entry form.**
12. Unreasonable delay. See USBC Rule 11. Events must be completed in time allotted.
13. The Tournament Secretary will settle all disputes not covered by USBC. We reserve the right to reject any entry or bowler.
14. Premature termination of the tournament brought about by war, national emergency or emergency causes relating thereto or therefrom, fire, natural disaster or any other reason beyond the control of the Tournament Committee shall cause, to the extent required thereby, all advertised prizes, guaranteed or otherwise, to be prorated in accordance with the number of entrants who have bowled in each of the respective events at the time of such termination.
15. Eligible persons who are not USBC Members can qualify for entry by paying an associate membership fee. Another option would be to pay a USBC participation fee.
